In order to increase the efficiency and effectiveness of work of the Corporation and to have a wider choice of officers, the Board of Directors vide decision taken at its 85<sup>th</sup> meeting held on 16.04.2021, decided that the full-time Managing Director of the Corporation may be appointed from either Engineer-in-Chief or Chief Engineer working in PWD B&R or an officer who has retired as Engineer-in-Chief or Chief Engineer of PWD (B&R). It is further submitted that vide Memo No. 9/60/09-3B&R (W) dated 25.08.2009 (Copy enclosed at **Annexure-F(3)**), the Pay Scale approved for the post of Managing Director is Rs. 37,400-67,000+10000 Grade Pay which is equivalent to the Pay scale of a Chief Engineer. This Pay scale was revised after adoption of 7<sup>th</sup> Pay Commission and is now equivalent to Level 19 of Pay Matrix Level specified by Haryana Civil Services Revised Pay Rules, 2016. (**Annexure-F(4)**)

It is further brought to the notice of the Board that from year 2009 to year 2019, Chief Engineers from PWD (B&R) have been appointed as Managing Director of the Corporation. Since 2019, only Officials ranking Engineer-in-Chief from PWD B&R have been appointed as Managing Director of the Corporation.


