Now the matter has been examined by State Government and it is a specially mentioned that in case person retires from such service without many back in the parent cadre then as per provision of rules 6.19 (c) and 624 of Pb CSR Vol.-II he will not be eligible to draw pension on the basis demoluments drawn on such service, but will be eligible for pension on the basis of pay which he would have drawn under the Government had be not been sent on foreign service/deputation/ex-cadre posts etc. Any violation is these instruction will be viewed seriously and disciplinary action will be utilized against defaulter officials/officers.


